Longitude -74.381013°Take the New Jersey Turnpike to exit 7A.

- 1. After you pay the toll, take Route 195 east to exit 16A.
- 2. At the exit ramp, make a right onto Route 537 West.
- 3. You will pass a Wawa and a McDonalds on your right. Continue on 537 past the entrance to Great Adventure on your right. Look for the light that intersects with Rt 539 and make a left onto rt 539 south.
- 4. Continue down rt 539 for about 20 minutes.
- 5. Once rt 539 intersects with rt 70 you will see a WAWA on the left, after that light you will need to bear right where rt 539 and rt 530 meet. Continue on rt 539 south.

6.	The area is heavily forested so there are no great landmarks. Look for brown WMA signs for Greenwood WMA. The main parking lot is a large dirt parking area on the right hand side about a quarter-mile south of mile-marker 18. If you pass the intersection for rt 72 you went too far.
