Please abide by the following to keep everyone as safe as possible.

1. Please **DO NOT COME** if you feel sick. Or if you have been exposed to Covid-19 in the last 14 days, **DO NOT COME** If you are concerned about being exposed to the Corona virus Please do not enter if you are not willing to follow the rules. We have put together these rules and guidelines based on Government and AKC suggestions. Some of these guidelines are subject to change between now and the Specialty. Read the judging program thoroughly for any updates as guidelines may change.
2. **NO Blow drying allowed in the building at all.**
3. We will have 1 Entrance only door and 3 Exit only doors.
4. Mask's required by all exhibitors and stewards inside the building. Masks are to be worn over the mouth and nose.
5. Hand sanitizers and clean up sprays will be located in multiple areas of the building.
6. Everyone should wash hands as frequently as possible.
7. Bathrooms: We will have disinfecting spray for bathrooms to wipe anything you touch.
8. Avoid touching dogs that aren't yours.
9. We will be disinfecting surfaces around the facility periodically. (Entrance and Exit doors, tables, Chairs, door knobs etc.

Entries must be received by 6:00 pm Wednesday, September 16, after which time no entries may be accepted, cancelled, altered, or substituted. No telephone or verbal entries will be accepted. All changes and cancellations must be received in writing (email is acceptable) prior to closing, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by the American Kennel Club.

All entries must be on official AKC entry forms. Entries will be returned if they are illegible, incomplete, are submitted with incorrect fees, or are photocopied without the reverse side instructions and agreement included. Checks returned for insufficient fees will have the entry cancelled; acceptance of such an entry will only be made if the full fees, plus a \$20 administrative fee, are paid via certified check or money order & received prior to the start of judging. Express deliveries must include signature waiver permitting them to be left at the Secretary's address without receipt signature.

Entries received without signature release will be returned. Entries with email addresses will be acknowledged with an email receipt. KFCS is not responsible for non-delivery of emails due to delivery errors or spam blockers, and no further efforts will be made. Confirmations and judging schedules will be sent after closing.

Refunds: Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date; in the event that a dog is absent, disqualified, excused by the veterinarian or judge, or barred from competition by the Show Committee; or in the event that extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the Trial Committee make it impossible to open or complete the show/trial. No refunds to be made for bitches entered in obedience who come into season after the closing date.

Fax/email entries: Will not be accepted.

Entry Errors: Exhibitors are responsible for the correctness of entries. All entries which include an email address will be sent an entry verification email shortly after receipt. All errors will be corrected prior to closing; exhibitor errors discovered after closing cannot be corrected. Duplicate entries will not be refunded after closing. Overpayments of less than \$5 per dog will not be refunded.

Transfers to Best of Breed, Open/Master Jr Show classes, or a higher obedience level: If, after the close of entries for this event, a dog has completed the requirements for a championship or an obedience title, the dog may be transferred from the Dog or Bitch class to the Best of Breed class or to a higher level obedience class. Juniors can be transferred to Open or Master if the junior has fulfilled the requirements of the class after this show's closing date. Each of these transfer requests must be made in writing to, and accepted by, the Show Secretary at least **30 minutes prior to the start of any regular judging** for the show.

DISTRIBUTION OF SWEEPSTAKES PRIZE MONEY

10% of the entry fee will be retained by Club for expenses. The remaining 90% of the Sweepstakes entry (for each sweepstakes, Puppy & Veteran) will be divided among the winners as follows:

Two rings will be utilized. Obedience will start in one ring in the morning. Sweepstakes will start in the other ring approximately 1 hour after obedience concludes. Conformation will follow sweepstakes.

All dogs and bitches entered in Sweepstakes MUST ALSO be entered in Regular Class at this Speciality. At the regular entry. Entries must be made at the same time and on the same entry form as the regular classes, indicating in the space for "Additional Classes" in the entry in Sweepstakes.
