AKC approved tracking collars will be permitted in all stakes per AKC guidelines.

DIRECTIONS

Eastbound on Interstate 10 from Tucson, take Exit 281.
This is **Hwy 83**. (About 20 miles from Tucson)
Go South toward Sonoita approximately 19 miles.

At Milepost 40 ~ Empire Ranch Headquarters

From the North (I-10) turn left (east); from the South (Sonoita) turn right.
There will be signage at the entrance from the Highway.

The entrance is Road 900 ~ Stay on this road for 3 miles. It is paved!

At the stop sign turn left. "**Airstrip Group Site**" This is **Road 901**
At the "Y" bear to the right (Road 901). All roads have been widened.
Just past the restrooms, turn left into the **Group Site** Parking area.

In addition to the permanent restrooms there will be Porta-Pots. Water is available on site.
Please dispose of all trash and excess hay. The use of weed-free hay is not required!
Please spread horse manure. Bury the dog stuff!
