# DIRECTIONS

Eastbound on Interstate 10 from Tucson, take Exit 281. This is **Hwy 83**. (About 20 miles from Tucson) Go South toward Sonoita approximately 19 miles.

At Milepost 40 ~ Empire Ranch Headquarters

From the North (I-10) turn left (east); from the South (Sonoita) turn right. There will be signage at the entrance from the Highway.

The entrance is Road 900 ~ Stay on this road for 3 miles. It is paved! At the stop sign turn left. "Airstrip Group Site" This is Road 901 At the "Y" bear to the right (Road 901). All roads have been widened. Just past the restrooms, turn left into the Group Site Parking area.

In addition to the permanent restrooms there will be Porta-Pots. Water is available on site. Please dispose of all trash and excess hay. The use of weed-free hay is not required! Please spread horse manure. Bury the dog stuff!
