## Notice to Exhibitors

Exhibitors will be responsible for cleaning up after their dogs and themselves in and around the building and parking area.

By providing an email address on the entry form, you agree to electronic correspondence for confirmation letter and judging program. If you would like your confirmation letter and judging program sent via US Postal Service, you may either not provide your email address on your entry or you may specifically request USPS.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Test Committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the show, no refund of entry fee will be made.

Bitches in season: Bitches that come in season will have all of their entry fee returned upon notification.

Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

It is the responsibility of the person submitting the entry form to ensure accuracy of data on the entry form. In the event of errors or cancellation, no refund will be given after the published closing date.

Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

Dogs will be tested in the order that entries are received.

Ribbons will be awarded to each dog passing the Temperament Test.
