## Notice to Exhibitors

- If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.
- Refund for bitches in season: full refund, less processing fee up to the closing date. After closing date: amount paid less \$10/day.
- Refunds are mailed seven days after the event.
- No refund for duplicate entry.
- Withdrawal of entry before closing date will receive refund less \$7 processing fee.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- EXHIBITORS ARE RESPONSIBLE FOR COMPLETE, ACCURATE, AND LEGIBLE INFORMATION ON THEIR ENTRY FORMS; ILLEGIBLE OR INCOMPLETE EENTRIES CANNOT BE ENTERED IN THE TRIAL.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and /or children. Any exhibitor whose dogs and /or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any fees paid will be made.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run.
- Please be courteous and pick up after your dog.
- Dogs under four months of age are prohibited at AKC Agility Trials
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccine is required in the State of California

An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is extremely contagious disease that can lead to severe illness and in some cases death. By entering and attending this trial, you are voluntarily assume all risks related to exposure to COVID-19.

## FCAT

Inspection will be on the honor system. Day of entries will be accepted until noon. All day of entries will run in the last group after pre-entered dogs.

### Trial Hours:

**8:30 am until completion**

First Dog: 9:00 am

Open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and spayed neutered dogs are eligible to participate. A dog may enter only once per event—defined by an event number.

### AKC Section 3.2

Bitches in season, or bitches which come in season after the close of entries, shall be barred from participating in the test or trial and their entry fees refunded. Notification to the Field Secretary of bitches in in season must be made before or during the roll call. Bitches known to be in season shall not be brought onto the FCAT area of the grounds. After closing bitches in season will receive a refund of amount paid less \$10/day. Refunds are mailed in the time frame of seven days before to seven days after the event.

The Test Committee reserves the right to bar known aggressive dogs. The Test Committee reserves the right to alter the track as required by weather and/or field conditions on the day of the test.

A penalty of \$10.00 will be assessed for any loose dog not competing while the test is in progress.

### Tests offered and Other Important Information

Two separate tests are being offered each day. You may use a single entry form per dog to enter one or all of the tests by circling the information on the entry form. Each test requires a \$20 entry fee for pre-entered dogs. Late entries and day of entries \$30. conditional entries will not be accepted.

Electronic timers may be used. A powered continuous loop system will be used with white or colored plastic streamers and/or for the lure.

Course will be fenced.

**Be sure your dog can be caught at the end of the course.**

No Bitches in Season.

After closing bitches in season will receive a refund of amount paid less \$10/day

## INSTRUCTIONS

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners<sup>SM</sup>** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

**Junior Handlers** should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
