### **DIRECTIONS:**

From I-5 north or south (and HWY 99 north or south): Take exit 525B to HWY 99 north.

Take exit 309 To W Elverta Rd. Turn left on Gibson Ranch Park Rd. (If you go over the bridge, you've gone to far.) Once in the park, continue straight on the main road, which will curve around to the right. Grounds are on the right, parking for the show is in the small parking lot on the right.

From I-80: From the east take exit 100 onto Antelope Rd. Turn left on Elverta Rd. Turn right on Gibson Ranch Park Rd. (Just past the bridge.) Continue as above.

From the west: Coming from west of Sacramento, take I-80 towards Reno. Take exit 91 to Raley Blvd.

Turn right on Elkhorn Blvd, then left on 28th St. Turn left on Elverta Rd. and continue as above.

Coming from Sacramento, take Watt Ave. Turn left on Elverta Rd. and continue as above.

### **TEST OFFERED: FAST CAT TEST**

FAST CAT Tests are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate. Females in season may not enter. A dog may enter only once per event. (An event is defined by an event number.) GO TO AKC.org TO REGISTER A CANINE COMPANION.

The FAST Cat test is a timed 100 yard dash. The dog is released at the starting line by one person and then must be caught by a second person at the finish line.

**TRIAL HOURS: 12:00 PM until both  
tests are completed**

**ROLL CALL: 45 MINUTES AFTER COMPLETION  
OF THE SECOND SSIH SPECIALTY  
SHOW.**

Inspection starts 1/2 hour prior to roll call for the first test. Any dog not present at the roll call time above for a test will be scratched. Racing for the first test will start as soon as dogs are checked in. Racing for the second test will start after the conclusion of the first test.

A battery powered continuous loop system will be used with white or colored plastic streamers and/or fur for the lure. Back-up equipment will be available.
