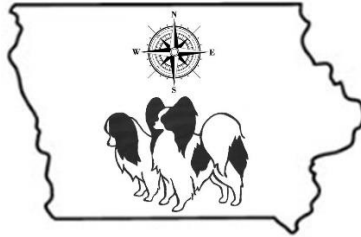

Entry Method

First Received with preference for Papillons. All entries will be accepted on the opening date, but only entries for Papillons will be entered into the trial for the first 2 weeks. All other entries will be put on a waiting list. On July 15, 2021, at 8 am CDT, those entries will be entered in the trial in the order received until the trial limits are reached. Entries received on or after July 15, 2021 at 8 am CDT will be entered in the trial with preference Papillons entered first and then in order of receipt regardless of breed until the trial limits are reached.

\$20.00 for each additional entry of the same dog each day

After Closing Wait List: A wait list of up to 25 runs for each trial will be maintained for these trials once they have closed on August 18, 2021. The wait list will be active until it's deadline on Monday, August 30, 2021. Any runs that are entered in these trials at closing and pulled before the wait list deadline will be replaced, if possible, by runs in order on the wait list, and the exhibitor will be reimbursed in full. If a run is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the run. Entry fees for runs on the wait list that do not get into the trial by the wait list closing date will be refunded in full.

Confirmation of Entry: Email confirmation of entries will be sent when entered. Please open and read so any corrections can be made at that time. Please make sure your email address is legible and valid.

Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

OBSTACLES – shall meet the specifications for obstacles in the current edition of Regulations for Agility Trials.

DOGS ELIGIBLE TO ENTER – This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word “dog” is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

MEASURING and HEIGHT CARD INFORMATION- When filling out the entry form, there is a section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the Judge of Record PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a Volunteer Measuring Official (VMO) or an Agility Field Rep is present; ALL dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog before its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores

Move Ups: For Friday's trial: Move-ups close at 6 pm CDT Monday, August 30, 2021. Move-ups may be sent by regular mail or email to the Trial Secretary.

For Saturday and Sunday trials: Move-ups close 30 minutes after the end of the trial on Friday and Saturday, respectively and must be submitted at the trial.

Refunds

Entry fees will be refunded in full if a written request is received by the Trial Secretary on or before the trial closing date. The club will refund the entry fee minus \$5 per run for bitches in season if a written request and a certificate or letter from a veterinarian is received by the trial secretary prior to the start of judging. The club will refund all by \$10 of the entry fee per day for injured dogs or handlers if a written request and a veterinarian's or doctor's letter is provided within one week of the start of the trial.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Please Note: NO phone or FAX entries will be accepted or scanned. Entries received without signature, fees or agreement will be returned. Exhibitors are responsible for complete, accurate and legible information on the entry forms. Illegible or incomplete entries will be returned to exhibitors.

NOTICE TO EXHIBITORS

Safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from the competition by action of the Trial Committee. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and or children. Any exhibitor whose dogs and or children engage in unsafe or disruptive behavior or create unnecessary disturbances, may, at the discretion of the trial committee, be asked to leave the trial site. In such a case, no refund of any fee paid will be made.

PCA does not agree to arbitrate claims as set forth on the official AKC entry form for this event.

PCA, their Board Members, and the Quad City Dog Center LLC, will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury, and/or death of dogs entered in this event.

All handlers must pick up after their dogs at the trial site and all hotel sites. Anyone not cleaning up after their dog will be requested to leave. No refunds will be given.

All dogs must be on leash at all times on the show grounds except in the ring and at the designated warm-up area.

Corrections must be made before the close of the trial!

Prizes and Awards

Only qualifying scores are eligible for awards. Rosettes will be awarded to first through fourth place in each height division in each class. A green rosette will be awarded for each qualifying score. MACH and PACH rosette and bar will be presented to dogs completing those titles. A rosette only will be awarded for a PAX. If you and your dog are close to a MACH, PACH or PAX please notify the trial secretary. All rosettes and prizes must be claimed the day of the show. None will be mailed.

PAPILLION ONLY SPECIAL AWARDS

The following special awards will be awarded each day:

HIGH IN TRIAL – Regular and Preferred

HIGH SCORING Breed Champion

HIGH SCORING Phalene

HIGH SCORING Junior Handler

These prizes will be awarded to the dog/handler team earning a Double Q in Standard (Preferred) and Jumpers With Weaves (Preferred) with the highest combined YPS (yards per second). If there is no Double Q, the dog with the highest YPS in Standard (Preferred) will earn the award. In case of a tie, the dog with the highest YPS in Standard (Preferred) will be the winner.

Any dog/handler teams eligible for High Scoring Breed Champion, Phalene, or Junior Handler must sign up by 10:00 a.m. on the day of each trial.

Friday, September 3, 2021, will be designated as the Papillon National Agility Day. There will be additional donated prizes on Friday only for:

High Scoring Excellent – Regular and Preferred

Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

For Exhibition Only (FEO)

FEO allows exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes. Competitors must enter in T2B and/or FAST. Participation in FEO is nonqualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring. Toys must be non-audible, may not leave the handler's hand, and cannot roll freely.
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time.

Fix and Go On (FNG)

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

AGILITY TRIAL MOVE-UP FORM

MOVE UPS WILL BE ALLOWED "DAY TO DAY"

Chapter 1, Section 20 of the *Regulations for Agility Trials* states:

Day-to-day Move-Ups: Move-ups from day-to-day at a set of back-to-back agility trials shall be at the discretion of the club.

The request for moving up must be made in writing at the trial site to the Trial Secretary not later than the day preceding the event. Verbal changes will not be accepted. All Email move-ups will receive a return confirmation from the trial secretary, who is not responsible for undelivered move-up request. Move ups during the trial must be given to the trial secretary by the end of the judging day.

Pre-Trial move up deadline: 5:00 pm CST Monday, July 5, 2021.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine PartnersSM** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
