Illegible entries will not be processed and will be returned to the exhibitor or shredded. Please make sure we can read your entry! Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

Wait List – Norcal GRC is offering a wait list to fill openings created by withdrawn entries prior to the trial's closing date/time. A maximum of **15 entries** will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to November 17, 2021, 5:00 pm. No entries may be withdrawn with a refund after closing on November 17, 2021, 5:00 pm. If a withdrawn entry is replaced by a wait listed entry, the original entry and check will be shredded. Any wait listed entry that does not move off the wait list into the trial will have the original entry and check shredded.

Bitches in season: Full refund will be given for bitches in Season after the closing date. You must request a refund in writing to receive a refund. The request must be received by the Trial Secretary no later than 30 minutes prior to the start of judging.

OBEDIENCE CLASS AWARDS

(Qualifying scores are required for all ribbons and awards)

Obedience Classes:

There will be separate awards for Golden Retrievers. All-breed awards will also include Golden Retrievers.

Magnets will be given for UDX legs and new titles earned.

First Prize..... Blue Flat Ribbon

Second Prize..... Red Flat Ribbon

Third Prize.....Yellow Flat Ribbon

Fourth Prize..... White Flat Ribbon

Qualifying Score in each class..... Green Flat Ribbon

Highest Scoring Dog in the Regular Obedience Classes..... Blue & Gold Rosette

Highest Scoring Dog in Open B & Utility B combinedBlue & Green Rosette

In the case of a tie for any prize, any dog that is not present for a run-off will forfeit its rights to the prize.

No awards will be mailed or delivered. An exhibitor whose dog is eligible for an award must be present or appoint a representative to accept the award.

Ground Rules:

1. NO overnight & NO day of RV parking.
2. NO smoking allowed on the grounds.
3. You will not be allowed to leave your vehicle idling in the parking area.
4. There will be a door monitor, you may not enter the building on your own.
5. When entering the building you will enter through the front door and exit through the back door.
6. Once you exit the ring you will need to exit the building.
7. You may not be allowed to watch from inside the building.
8. Check - in will be done outside the building.
9. Crating – there will be **NO** crating in the building. You will be required to crate from your vehicle. Bring canopies and/or shade cloth. Please keep dogs quiet, if barking cannot be controlled you will be asked to leave. Keep dogs on leash while not working. **Note:** farm animals and cats on property. Air your dog on Gravel driveway. Do not air on grass, plants, barn or equipment. **Note:** water is well water and safe to drink.
10. **Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Covid 19 – best practices:

1. Do not come to this event if you feel sick.
2. Participants are required to follow state, local and facility guidelines that are in effect at the time of the event.
3. You may be required to wear a mask while in the building. If so you may not enter the building if you are not wearing a mask, which means you will be required to wear a mask in the ring while competing with your dog. You must bring your own mask!

ADDITIONAL TRIAL RULES

Every precaution for the safety of dogs and exhibitors will be exercised, but neither the Club nor the management will be responsible for loss or injury.

Only dogs that are eligible to be shown under AKC rules shall be allowed within the show precincts.

All dogs must be **ON LEASH** at all times while on show grounds and parking areas unless in the ring for judging.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Consult the judging schedule for the time of judging. Exhibitors and handlers are responsible for the presence of their dogs in the judging ring. The Club assumes no responsibility for this.

CATALOG ORDER: As far as is practical, all entries will be arranged according to jump height, in descending order for all obedience classes that require jumps.

Print or type entries carefully, using BLACK or BLUE ink. The Club accepts no responsibility for incorrect or illegible entries. Entries that are received unsigned, without the proper entry fee or without both sides of the form, will not be accepted.

No entries can be changed or refunded after the closing date.

Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date, nor in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Trial Committee. If, because of riots, civil disturbances, fire, act of God, act of a public enemy, strikes, extreme weather conditions (including, but not limited to, extreme heat, snowstorms or hurricanes) or any other act beyond the control of the management it is impossible to open or to complete the Trial, no refund of entry fee will be made. **Entries will be refunded only if the trial is cancelled due to Covid19.**

Acknowledgement of receipt of entries will be made soon after closing date. **Confirmations and judging schedule will be emailed only.** Please include your email address on your entry form. Should such acknowledgement not be received by an exhibitor five days prior to the trial, please contact the Trial Secretary.

No move-ups will be allowed at this trial.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in

- Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT
