Other Items Exhibitors May Need To Know

- **CONDITIONAL, UNSIGNED, INCOMPLETE** or telephoned entries cannot be accepted. Entries without fees cannot be accepted. The entry form must include the Agreement paragraphs on same page with the Entry Form.
- **ENTRIES NOT ON OFFICIAL AKC FORMS** or photocopies of entry forms without the agreement and rules on the reverse side of the official AKC entry form are **NOT ACCEPTABLE**.
- **OWNERS ARE RESPONSIBLE FOR ERRORS** on entry blanks, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete, regardless of who makes such errors. Changes, additions, or corrections to entry forms must be received in writing prior to close of entries. Changes by telephone are not acceptable.
- **BITCHES IN SEASON** are not permitted to compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. A processing fee of \$15.00 per entry will be retained. A signed veterinarian's letter stating the bitch is in season must be provided as documentation with the request or within one week of the trial at the latest to receive a refund.
- **ENTRY FEES WILL NOT BE REFUNDED** in event of errors or cancellation of entries after the published closing date, nor in the event a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by the Trial Committee. If because of riots, civil disturbances, loss of site, extreme weather conditions (including, but not limited to, extreme heat, snowstorms, hurricanes, floods, or earthquakes), or other acts beyond the control of the management, it is impossible to open or complete the trial, no refund of entry fees will be made. The safety and well-being of the dogs, exhibitors, and judges is of paramount importance.
- **ELECTRONIC CONFIRMATION OF ENTRY, JUDGING PROGRAM and MARKED CATALOG** will be sent to the email address on the Official AKC entry form after the closing date. If the exhibitor wishes to have a printed schedule mailed, please request on the entry form. If an exhibitor has not received a copy of the schedule within seven days of the trial, the Trial Secretary should be contacted. (Please check your Spam folder before contacting the Secretary.)
- **DOGS NEED TO BE AT THE TRIAL** only at scheduled time of judging and may leave immediately after unless required for further judging.
- **DOGS MUST** be kept on leash except when being judged in the ring.
- **UNENTERED DOGS** are not permitted on the trial grounds.
- **THERE SHALL BE NO drilling** nor intensive or corrective training of dogs on the show grounds or premises.
- **NO OVERNIGHT and NO day of RV parking.**
- **NO SMOKING** allowed on the grounds.
- **VEHICLES MAY NOT BE LEFT** idling in the parking area

- Do not come to this event if you feel sick! If the club is able to fill your entries from the wait list, your entry fees will be refunded.
