- Magnets will be given for either RAE or RACH legs and for new titles earned.
- In the case of a tie for any prize, any dog that is not present for a run-off will forfeit its rights to the prize.
- No awards will be mailed or delivered. An exhibitor whose dog is eligible for an award must be present or appoint a representative to accept the award.

GROUNDS RULES:

- 1. NO OVERNIGHT & NO day-of RV parking.

this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

SPECIAL NOTICE RELATED TO THE COVID-19 VIRUS:

- 1. Do not come to this event if you feel sick. If the club is able to fill your entries from the wait list, your entry fees will be refunded.
