- Exhibitors MUST specify their dog's jump height for Advanced, Excellent and Master classes.
- Rally classes with jumps will be judged in ASCENDING order.
- Rally ring size will be a minimum of 45' x 60'

Illegible entries will not be processed and will be shredded or returned to the exhibitor. Please make sure we can read your entry! Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

Wait List – NORCAL GRC is offering a wait list to fill openings created by withdrawn entries prior to the trial's closing date/time. A maximum of **15 entries** will be placed on the club's wait list. All entries, including wait-listed entries, must be received by the Trial Secretary prior to September 22, 2021, 5:00 pm. No entries may be withdrawn with a refund after closing on September 22, 2021, 5:00 pm. If a withdrawn entry is replaced by a wait-listed entry, the original entry and check will be shredded. Any wait-listed entry that does not move off the wait list into the trial will have the original entry and check shredded.

Bitches in season: Full refund will be given for bitches in Season after the closing date. You must request a refund in writing to receive a refund. The request must be received by the Trial Secretary no later than 30 minutes prior to the start of judging.

RALLY CLASS AWARDS

Qualifying scores are required for all ribbons and awards

There will be separate awards for Golden Retrievers. All-breed awards will also include Golden Retrievers.

First Prize Blue Flat Ribbon
Second Prize..... Red Flat Ribbon
Third Prize Yellow Flat Ribbon
Fourth Prize..... White Flat Ribbon
Qualifying Score in each class Green Flat Ribbon
Highest Combined Score in Rally Advanced B & Excellent B Blue & Green Rosette
Highest Triple Qualifying Score in Rally Blue & Red Rosette

- Magnets will be given for either RAE or RACH legs and for new titles earned.
- In the case of a tie for any prize, any dog that is not present for a run-off will forfeit its rights to the prize.
- No awards will be mailed or delivered. An exhibitor whose dog is eligible for an award must be present or appoint a representative to accept the award.

GROUND RULES:

1. NO OVERNIGHT & NO day-of RV parking.
2. NO SMOKING allowed on the grounds.
3. VEHICLES MAY NOT BE LEFT IDLING in the parking area.
4. There will be a door monitor, you may not enter the building on your own.
5. When entering the building you will enter through the front door and exit through the back door.
6. Once you exit the ring you will need to exit the building.
7. You may not be allowed to watch from inside the building.
8. Check-in will be done outside the building.
9. Crating – there will be **NO** crating in the building. You will be required to crate from your vehicle. Bring canopies and/or shade cloth. Please keep dogs quiet, if barking cannot be controlled you will be asked to leave. Keep dogs on leash while not working. **Note:** farm animals and cats on property. Air your dog on the gravel driveway. Do not air on grass, plants, barn or equipment.
Note: Water is well water and safe to drink.

10. **Exhibitors are responsible for cleaning up after their dog(s).** Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

SPECIAL NOTICE RELATED TO THE COVID-19 VIRUS:

1. Do not come to this event if you feel sick. If the club is able to fill your entries from the wait list, your entry fees will be refunded.
2. Participants are required to follow state, local and facility guidelines that are in effect at the time of the event. This may include wearing a mask and social distancing while on the grounds.
3. You may be required to wear a mask while in the building. If so, you may not enter the building if you are not wearing a mask, which means you will be required to wear a mask in the ring while competing with your dog. You must bring your own mask!

ADDITIONAL TRIAL RULES

- Every precaution for the safety of dogs and exhibitors will be exercised, but neither the Club nor the management will be responsible for loss or injury.
- Only dogs that are eligible to be shown under AKC rules shall be allowed within the show precincts.
- Dogs must be **ON LEASH** at all times while on show grounds and parking areas unless in the ring for judging.
- NO DRILLING nor intensive or corrective training of dogs on the show grounds or premises.
- Dogs need to be at the trial only at scheduled time of judging and may leave immediately after unless required for further judging.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- Consult the judging schedule for the time of judging. Exhibitors and handlers are responsible for the presence of their dogs in the judging ring. The Club assumes no responsibility for this.
- **CATALOG ORDER:** As far as is practical, all entries will be arranged according to jump height, in ascending order for all rally classes that require jumps.
- Print or type entries carefully, using BLACK or BLUE ink. The Club accepts no responsibility for incorrect or illegible entries. Entries that are received unsigned, without the proper entry fee or without both sides of the form, will not be accepted.
- No entries can be changed or refunded after the closing date.
- Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date, nor in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Trial Committee. If, because of riots, civil disturbances, fire, act of God, act of a public enemy, strikes, extreme weather conditions (including, but not limited to, extreme heat, snow storms or hurricanes) or any other act beyond the control of the management it is impossible to open or to complete the Trial, no refund of entry fee will be made. **Entries will be refunded only if the trial is cancelled due to Covid19.**
- **CONFIRMATION OF ENTRY AND JUDGING PROGRAM WILL BE SENT BY EMAIL ONLY** to the email address listed on the Official AKC entry form soon after the closing date. If an exhibitor has not received a copy of the schedule within five days of the trial, the Trial Secretary should be contacted. (Please check your Spam/Junk folder before contacting the Secretary.)

INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person.
