Entries must be received by 6:00 pm Wednesday, September 22 2021, after which time no entries may be accepted, cancelled, altered, or substituted. No telephone or verbal entries will be accepted. All changes and cancellations must be received in writing (email is acceptable) prior to closing, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by the American Kennel Club.

All entries must be on official AKC entry forms. Entries will be returned if they are illegible, incomplete, are submitted with incorrect fees, or are photocopied without the reverse side instructions and agreement included. Checks returned for insufficient fees will have the entry cancelled; acceptance of such an entry will only be made if the full fees, plus a \$20 administrative fee, are paid via certified check or money order & received prior to the start of judging. Express deliveries must include signature waiver permitting them to be left at the Secretary's address without receipt signature.

Entries received without signature release will be returned. Entries with email addresses will be acknowledged with an email receipt. KFCS is not responsible for non-delivery of emails due to delivery errors or spam blockers, and no further efforts will be made. Confirmations and judging schedules will be sent after closing.

Refunds: Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date; in the event that a dog is absent, disqualified, excused by the veterinarian or judge, or barred from competition by the Show Committee; or in the event that extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the Trial Committee make it impossible to open or complete the show/trial. No refunds to be made for bitches entered in obedience who come into season after the closing date.

Fax/email entries: Will not be accepted.

Entry Errors: Exhibitors are responsible for the correctness of entries. All entries which include an email address will be sent an entry verification email shortly after receipt. All errors will be corrected prior to closing; exhibitor errors discovered after closing cannot be corrected. Duplicate entries will not be refunded after closing. Overpayments of less than \$5 per dog will not be refunded.

Transfers to Best of Breed, Open/Master Jr Show classes, or a higher obedience level: If, after the close of entries for this event, a dog has completed the requirements for a championship or an obedience title, the dog may be transferred from the Dog or Bitch class to the Best of Breed class or to a higher level obedience class. Juniors can be transferred to Open or Master if the junior has fulfilled the requirements of the class after this show's closing date. Each of these transfer requests must be made in writing to, and accepted by, the Show Secretary at least **30 minutes prior to the start of any regular judging** for the show.

EXHIBITORS Friday night setup will be available from 5:30- 7pm.

Practice runs for both obedience and conformation, including ramp practice, will be available for \$5 Per Run from 6-7pm

Additional protective matting must be put under dog crates to protect flooring.

I (we) acknowledge that the Rules Applying to Dog Shows and, if this entry is for an Obedience Trial, the Obedience Regulations, have been made available to me (us), and that I am (we are) familiar with their contents. I (we) waive any and all claims or causes of action, I (we) might otherwise have against the AKC and any AKC-approved judge, judging at this show, under AKC Rules, Regulations and Guidelines. I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss of injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence or any other person, or any other cause or causes. - A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. JUNIOR SHOWMANSHIP

Novice class: For junior handlers aged 9-17 who, at the time entries close, have not won three first place awards with competition present in Junior Showmanship Novice class at a licenses or member show.

Open class: For junior handlers aged 9-17 who, at the time entries close, have won three first place awards with competition present in Junior Showmanship Novice class at a licenses or member show.

Master class: For junior handlers aged 9-17 who, at the time entries close, have won 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition the calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

PLEASE NOTE: Juniors must include their AKC Junior Handler number on the entry blank. Be sure all information for Junior Showmanship Classes is entered on the front and back of the entry form.

Dogs shown in Junior Showmanship may have Full or Limited AKC registration or have an ILP/PAL number. Altered animals are eligible to be shown, but bitches in season are not eligible.
