**Coming from the close North-** head south on 99W toward Newberg, turn right on 99W, which then becomes Roy Rogers

**Coming from the far North or South on I-5** - take Exit 289, Tualatin-Sherwood Road, go approximately 4.5 miles until you hit 99W, go straight across 99W, T/S Road becomes Roy Rogers

**From the East-** Take 205 until it hits I-5, then proceed as above

**Once on Roy Rogers,** go 2.4 miles turn right onto SW Elsner Road, after the 1<sup>st</sup> curve, **SLOW DOWN**

The Cash's driveway is on the right turn between white fencing at 17720.

There parking behind the Arena and to the side if the front part is filled. **There is no RV parking available on site.**

From the Cash's, turn left out of their driveway. Turn Left onto Roy Rogers. Stay on Roy Rogers, when you cross 99W,

The Road turns into Tualatin Sherwood Road. In about 4 miles, turn right onto Martinazzi (there will be a Fred Meyers on you left as you turn), turn right on SW Warm Springs, turn right onto SW Tonka, the destination will be on your right. You will see a bright red **Emergency**

### NOTICE TO EXHIBITORS

The American Kennel Club Rules and Regulations will govern these Shows and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium list.

**ENTRY INFORMATION:** Entries close at 12:00 noon PDT, October 6, 2021, or when a total of 8 hours of judging time per judge has been reached. Fees must accompany entries. **All checks and money orders should be made payable to Sherwood Dog Training Club or SDTC, mailed or delivered to Trial Secretary, Jill Faulmann, 20405 SW 216<sup>th</sup> Place, Sherwood, OR 97140**

Telephone, telegraph and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent, or if the dog is entered in a class in which it is not eligible to compete. THE RESPONSIBILITY FOR THE COMPLETENESS OF ANY ENTRY RESTS SOLELY WITH THE ENTRANT. Entry fees shall not be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly.

-The Secretary will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show, no refund of entry fees will be made.

No Entry fees will not be refunded for after the closing date except for Bitches that come into season. For this reason a refund less \$4.00 per class upon written request of the owner or handler before the start of judging of the Trial on the day of the Trial will be given.

**THIS CLUB DOES NOT AGREE TO ARBITRATE CLAIMS AS SET FORTH ON THE OFFICIAL AKC ENTRY FORM FOR THIS EVENT.**

**JUDGING:** The judging will start promptly as specified in entry confirmation. Dogs may arrive anytime prior to their time of judging, and may leave immediately thereafter, unless required for further judging. The Club will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of class judging. Owners or agents alone are responsible for the presence of their dogs in the judging ring. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class; it is not the responsibility of the ring steward to locate any dog, its owner or its agent when the dog's presence is needed in the judging ring. Judges will NOT wait for any dog holding up a class.

**ACKNOWLEDGMENTS: If you provide an e-mail address on your entry you agree that judging programs and armband numbers may be sent to you via e-mail.** Acknowledgments, arm band # and judging program will be sent after closing via email. Should exhibitor NOT receive an acknowledgment within a reasonable time, contact the Trial Secretary at (503) 625-3647. Anyone wishing a mailed copy of the schedule must provide a self-addressed stamped envelope to the Trial Secretary.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship. 3.(Event Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division. 4. A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
