This will be a CONCURRRENT Trial using a BLOCK schedule.

NO RUN ORDER! A time block will be assigned.

An email explaining the process will be sent out prior to the trial.

Fast CAT events are open to all dogs at least 12 months of age that are registered with the AKC, dogs granted a Purebred Alternative Listing (PAL) number, dogs with limited or Conditional Registration and dogs enrolled in the Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate. If your mix breed dog needs an AKC Canine Partner number a form and information is available on page 5 in this Premium. Dogs may only run once per test.

#### Hours

Grounds will be available a half hour prior to trial hours. Trial hours are usually 8:00AM until 3:30PM or until all runs are completed. It is also the responsibility of each entrant to be ready with catcher and releaser when their dog is called to the line.

Collar Rules: Dogs may run without a collar or wear any type of collar except choker collars, electronic training collars or head collar. Collars should be snug. Hanging tags pose a safety concern and it is suggested that tags be secured to the collar with tape. Dogs may run muzzled if desired. Clips or rubber bands may be used to keep long hair from falling across the dog's field of vision.

#### Check in & Inspection.

Check in/Inspection starts 15 minutes prior to the beginning of the trial and each time block or throughout the event. Every dog must pass through inspection before each run. Dogs who miss their time block will be skipped. If you do not check in within one hour prior to the end of the trial closing, we will assume you are absent. No refunds for absent dogs. At inspection, all dogs will be examined for disqualifications. Bitches known to be in season are not to be brought to the test. At inspection, bitches in season, lame and unfit dogs will be excused with entry refunded minus a \$3.00 service fee per run.

#### Refunds!

You may pull out of the trial prior to closing date/time for a refund minus a \$3.00 service fee per entry run per dog. There will be no refund after closing for any reason, including injury or illness to human or dog unless the limit has been met and there is a waitlist participant to take your spot.

### What is the Fast CAT?

- 1. Fast CAT is a timed straight 100-yard dash for dogs.
- Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen. The course is completely fenced, and dogs are run individually.
- Dogs are timed when they complete the 100-yard dash. The time is converted to Miles Per Hour (MPH).
- Based on the dog's size at the withers a handicap is applied and points are eamed:
- 18" or greater = Handicap is 1.0
- 12" up to less than 18" = Handicap is 1.5.
- Under 12" = Handicap is 2.0.
- FORMULA: MPH X HANDICAP = POINTS
- Titles are earned at specific point levels.

BCAT = 150 points, DCAT = 500 points, FCAT = 1,000 points

FCAT# = Each additional 500 points

\*ACCORDING TO AKC RULES; Handlers are not permitted to run with a dog during an official run. Handlers are not to entice the dog through the course with anything other than the lure during its official run. NO mechanical devices including whistles, horns, bull horns, etc. Or toys including the waving of objects to lure the dog to the finish line. You MAY CHEER and use the dog's name only.
