No entries will be accepted by phone, fax, or hand delivery. Express mail entries must include the signature waiver allowing them to be left at the address above. No entry shall be made, and no entry shall be accepted which specifies any conditions as to its acceptance.

Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$30.00 collection fee to the amount of each returned check.

FIRST RECEIVED ENTRIES

Entries will open at 5:00 pm CST, both online and by mail. If entering by mail a check for the correct amount must be included. If using PayPal, please send by "Family & Friends" for the total amount when you email your entry.

WAIT LIST

The American Beauceron Club is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of **20 entries per day** will be placed on the event wait list. No entries may be withdrawn with a refund after closing on December 16, 2022. If a withdrawn entry is replaced by a wait listed entry, a refund will be issued for the withdrawn entry after a \$10 processing fee is deducted. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial. **Bitches in season are not allowed at the trial site.**

CLASS TRANSFER

Move-ups between Trials 1 and 2 on Saturday and Sunday will be offered. A move-up transfer, formally known as move-up, is a request for class transfer. It must be submitted to the Secretary in writing and presented to the Trial Secretary before running in that class element.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

Dogs may enter two different levels within each element, at each trial. Dogs entering Advanced, Excellent, or Master classes must have earned the prerequisite title, as stipulated in the AKC Scent Work Regulations.

Dogs may enter either the Novice "A" class or the Novice "B" class—not both. **Novice A Classes** are open to dogs who have not completed any title for that particular element, who have not completed a comparable title with another organization, and whose handlers are neither Scent Work judges, nor have ever worked as professional detection dog handlers. **Novice B Classes** are open to all dogs.

CHECK IN

Exhibitors MUST check-in for EACH TRIAL entered

At check-in you will receive your armband number. The Trial Secretary, or their designee, will be on-site at the trial at 7:30 am CST to begin checking competitors in each day.

RIBBONS, AWARDS, & PRIZES

Qualifying and Placement ribbons will be awarded in each class as follows:

HIGH IN TRIAL

Teams who participate in all elements offered for the same difficulty level and qualify in each class are eligible to win High in Trial (HIT) for their level and by trial. One HIT winner is determined by adding the team's faults across the elements. The team with the fewest faults will be declared HIT. If there is a tie based on faults, then the team's times across the elements will be summed and the fastest-finishing team wins. HIT winners will receive a rosette. All ribbons must be claimed by the end of the trial on Sunday; no ribbons will be mailed.

Junior High in Trial will be awarded to juniors who participate and qualify in the most elements with the fewest faults. Junior HIT winners will receive a rosette.

A HIT rosette will be awarded to a qualifying **Beauceron** team each day.

A HIT rosette will be awarded to a qualifying **Australian Shepherd** team each day.

TRIAL SITE

Parking will be in designated areas on grass. Please follow parking steward instructions and observe all signage. There are eight (8) **RV Camping Spaces** available at \$25/night. Please contact **Sharon Londoño (985-630-1830)**, owner of Lagniappe Equestrian Center, directly to reserve a space and arrange payment.

Trial Site. It is not appropriate to scout and/or visit the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

Possession of Odors and Training. Chapter 5. Section 35 of the Scent Work Regulations state “No person other than those engaged in the administration of the trial shall be in possession of any of the target odors when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than in the designated warm-up area.”

Spectator Area. Spectators are allowed at the discretion of the judge running the element and the team.

Crating. No separate crating space will be available. Due to social distancing and spacing issues please keep dog crated in vehicles unless actively pottyng the dog or going to a search area.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal receptacles will be available at various locations around the trial grounds.

Staging Area(s) will be out of view of search area(s). The Staging Area will include warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results.

A **Warm-Up Area** will be available. One labelled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well.

The **Handler’s Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler’s Briefing the judge will explain if there’s an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler’s Briefing.

Search Area Conditions. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

Search Area Sizes Search areas may be of any shape, and of the size specified in the Regulations for each class.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

DIRECTIONS TO THE TRIAL SITE

From I-12: Take Exit 57 toward LA-1077 N and keep right following signs for Goodbee, merging onto LA-1077 N. At the traffic circle, take the first exit onto LA-1077 S (Turnpike Road). Take a right to stay on LA-1077 N, and then a left to stay on LA-1077 N. LA-1077 N becomes N. Willie Road, stay on the road for two miles, and then a right onto LA-40 E. After 2.4 miles, turn left onto LA-25 N/Orange Street (in Folsom) and continue for a mile. Then take right onto Verger Road. Google maps places the trial site west of where it actually is; continue past Skyward Farm and on through the gate and you will see the main arena on your left. Follow parking attendant instructions from there.

The American Beauceron Club reserves the right to decline future entries from the offending party. The American Beauceron Club accepts no responsibility, nor do they endorse, any individual accommodations.

OTHER TRIAL INFORMATION

We will have a trial photographer, and information on photos will be available prior to the trial.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

NOTICE TO EXHIBITORS

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Beauceron Club will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Beauceron Club reserves the right to decline entries

for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Beauceron Club, Lagniappe Equestrian Center, or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. Leashes may be of any length. The leash should be made of plain, pliable material. A wearable camera, such as a Go Pro, may be mounted to the dog's harness or handler's person, if desired.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds except during the actual search. Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

Lagniappe Equestrian Center is a workplace, and Sharon Londoño is kind enough to allow its use for this trial. Please be respectful and pay attention to your dogs and be mindful of the horses. Ask permission before entering non-trial fenced areas, and make sure to close all gates. Always clean up after yourself and your dogs. There are some shade trees, and pop-up canopies or tents are allowed in the parking areas. Crates and tents are not allowed in the trial areas. Ex-pens are not allowed, and dogs cannot be tied out to fences or other farm structure. Bring your own chairs and crates. Please be respectful of other competitors. A Porta-Potty will be on site for human use.

COVID-19 Regulations

Participants are expected to follow state, local government, facility and event guidelines for social distancing regarding COVID-19. Please check the AKC Scent Work website (www.akc.org/sports/akc-scent-work/) for the most up-to-date version of AKC guidelines. The club will inform participants of any state orders closer to the trial. Please be prepared to wear masks and have your dogs used to people wearing masks.

Due to COVID-19, food and beverage will not be provided on site for exhibitors. The nearest concessions are several miles away in downtown Folsom.
