Entry fees: \$27.00 for the first class entry of a dog (which includes AKC recording and event fees) and \$18.00 for each additional entry of the same dog in the same event number. There are 2 separate events each day. Four events total for the weekend

Entry fee calculation – There are 4 separate trials. If you are entering one class in each trial, your entry fee is \$28 per trial. The second entry fee discount only applies if you are entering more than one class in the same trial, not the same day.

Entries close at 6:00 PM, WEDNESDAY, Feb 15, 2023, at 6:00 PM at the Trial Secretary's Office, or earlier if the limits have been reached in all classes, after which time entries cannot be accepted, canceled or substituted, except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

SPECIAL NOTICES

Transfers will be approved in accord with Chapter 1, Section 15 of the Rally Regulations, provided that a written request is submitted to the Trial Secretary at least 30 min. prior to the start of the Trial, and that the limit has not been reached in the requested class. Transfers will be accepted on the day prior to the start of the trial.

Qualifying scores are required for all awards.

Catalogs available by pre order only. Please enclose \$3.00 with your entry fee

Exhibitors should plan to provide a crate for their dog.

Because of limited space, exercise pens will not be allowed in the building or in the parking area, and crates must be stacked, if necessary, to allow room for all exhibitors and dogs. Chairs must be placed in front of crates

Due to space restrictions, Toledo Kennel Club reserves the right to ask that no unentered dogs be allowed in the building, including the lobby area as provided in Chapter 11, Section 11 of the "Rules Applying to Dog Shows".

No Smoking is permitted in the Toledo Kennel Club Building.

A refund of all but \$3.00 of each entry fee per event will be made to an exhibitor with a bitch that has come into season after the close of entries, providing that a statement from a veterinarian is submitted to the Trial Secretary no later than one hour before the beginning of judging on the day of the Trial.

Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

The Toledo Kennel Club will follow all local, state & CDC guidelines in effect at the time of the trial

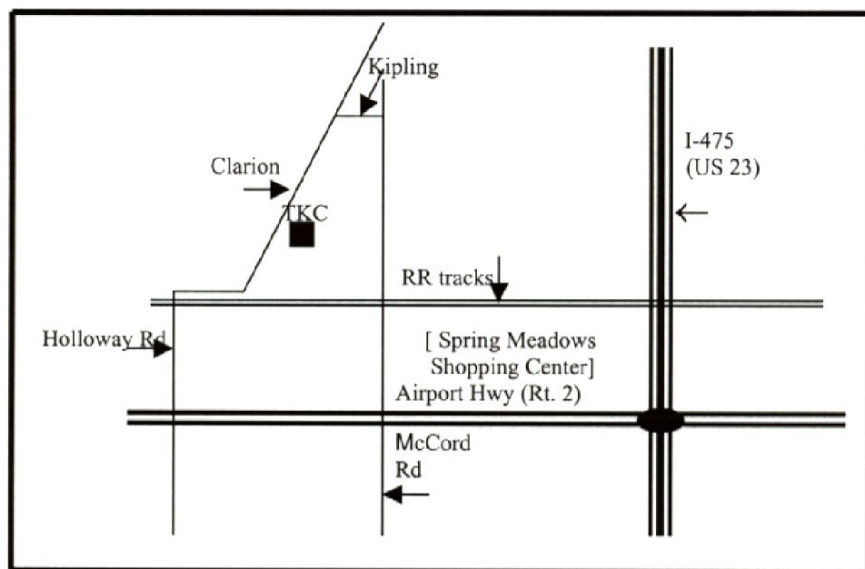

DIRECTIONS TO THE TRIAL SITE

From the North or South: U.S. 23/I-475 to Airport Hwy (S.R. 2), west to McCord Road (just after Springfield Mall), north to Kipling, west to Clarion, left to Toledo Kennel Club building.

From the East: U.S. 20 to I-75, south to I-475, north to Airport Hwy, then as above. Ohio Turnpike to Exit 59, north on Reynolds Rd., west on Airport Hwy, then as above.

From the West: Ohio Turnpike to Exit 52 (Toledo Express Airport), east on Airport Hwy (6.4 mi), north on Holloway Rd., bear right after RR tracks onto Front (becomes Clarion), .



NOTICE TO EXHIBITORS

Faxed, Emailed, Telephone and Unsigned Entries cannot be accepted. Entries Not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

Make All Checks and Money Orders payable to: Toledo Kennel Club. CANADIAN exhibitors must make fees payable in US FUNDS. Please mail checks or money orders with entries. The Trial Secretary assumes no responsibility for cash sent through the mail.

Mail All Entries with Fees to: Joanne Silhanek 6216 Reo St. Toledo, OH 43615. Entries received without fees will not be accepted. Acknowledgment of entries will be made as soon as possible after the closing date with the Judging Program and directions to the Trial Site. Should such acknowledgment not be received by the exhibitor within a reasonable time, please contact the Trial Secretary. **Overnight or express entries MUST have waiver of signature. Failure to do so may result in your entry not being picked up in a timely manner.**

AKC Event & Recording Fees will be required for the first entry of each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking test. The fees are to be collected by the trial-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the Fees are to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2). The recording and event fees are included in the entry fee.

No Entry shall be made, and no entry shall be accepted which specifies any condition as to its acceptance.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Trial Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the trial, no refund of entry fees will be made.

Post Dated and Returned Checks do not constitute a valid entry fee. The trial giving Club will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

Errors on Entry Blanks. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellations of entries after the published closing date.

Judges Will Not Wait for Any Dog Holding Up a Class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

All Dogs Present must be held on leash or confined to their crates except when being judged.

No gasoline or diesel generators are permitted inside of any building or within 100 feet of the show grounds on which this obedience trial is conducted. No electrical hookups will be available.

No Smoking is allowed in the building.

The grounds will not be available to the exhibitors and their dogs on the nights prior to the trials.

Neither the Trial Committee nor the Toledo Kennel Club will be responsible for the loss or damage to any dog on the trial grounds, whether as a result of an accident or any other cause. It is clearly understood that every dog entered in the trial is in the care, custody and control of its owner or handler during the entire time the dog is on the trial premises.

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.

3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

4. Dogs listed in the AKC Canine PartnersSM Program may be eligible to enter all-breed AKC Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. I (we) agree that the determination of whether the injury is serious shall be made by the event veterinarian and is binding on me (us).
