- Rally classes with jumps will be judged in ASCENDING order.
- Rally ring size will be a minimum of 45' x 60'

Illegible entries will not be processed and will be shredded or returned to the exhibitor. Please make sure we can read your entry! Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

Wait List – NORCAL GRC is offering a wait list to fill openings created by withdrawn entries prior to the trial's closing date/time. A maximum of **15 entries** will be placed on the club's wait list. All entries, including wait-listed entries, must be received by the Trial Secretary prior to February 24, 2023, 5:00 pm. No entries may be withdrawn with a refund after closing on February 24, 2023, 5:00 pm. If a withdrawn entry is replaced by a wait-listed entry, the original entry and check will be shredded. Any wait-listed entry that does not move off the wait list into the trial will have the original entry and check shredded.

Bitches in season: Full refund will be given for bitches in Season after the closing date. You must request a refund in writing to receive a refund. The request must be received by the Trial Secretary no later than 30 minutes prior to the start of judging.

RALLY CLASS AWARDS

Qualifying scores are required for all ribbons and awards

There will be separate awards for Golden Retrievers. All-breed awards will also include Golden Retrievers.

- Magnets will be given for either RAE or RACH legs and for new titles earned.
- In case of a tie for an award, a dog not present for a run-off will forfeit the right to the award.
- No awards will be mailed or delivered. An exhibitor whose dog is eligible for an award must be present or appoint a representative to accept the award.

Grounds Rules and Trial Procedures:

1. Crating will be allowed in the building.
 - Please put a clean towel or mat under your chair and crate to protect matting.
 - NO X-pens in the building.
 - NO crate aggressive dogs in the building.
 - A dog not entered in the trial is not allowed in the building.
2. Face masks:
 1. Wearing of face mask will most likely be required while in the building, so be prepared. It is likely you will not be required to wear a mask in the ring, but it is a possibility, so be prepared for that, too.
 2. Bring your own mask.
3. Spectators will not be allowed at this trial. If you need to come with someone not entered in the trial, please have that person wait at your car.
4. NO overnight & NO day of RV parking.
5. NO smoking allowed on the grounds.
6. You will not be allowed to leave your vehicle idling in the parking area.
7. Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

COVID – Best Practices:

Participants are, at a minimum, required to follow state, local and facility guidelines that are in effect at the time of the event. NORCAL GRC, Inc., and/or the Dream Big Training Center may impose additional requirements.

ADDITIONAL TRIAL RULES

- Every precaution for the safety of dogs and exhibitors will be exercised, but neither the Club nor the management will be responsible for loss or injury.
- Exhibitors are asked to refrain from bringing family and friends that are not showing dogs. This is to minimize the number of people on the trial site during the pandemic.
- Only dogs that are eligible to be shown under AKC rules shall be allowed within the show precincts.
- Dogs must be **ON LEASH** at all times while on show grounds and parking areas unless in the ring for judging.
- NO DRILLING nor intensive or corrective training of dogs on the show grounds or premises.
- Dogs need to be at the trial only at scheduled time of judging and may leave immediately after unless required for further judging.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- Consult the judging schedule for the time of judging. Exhibitors and handlers are responsible for the presence of their dogs in the judging ring. The Club assumes no responsibility for this.
- **CATALOG ORDER:** As far as is practical, all entries will be arranged according to jump height, in ascending order for all rally classes that require jumps.
- **RALLY MAPS** will be emailed after 6:00 PM the evening before the trial. Maps will be posted at the site as well. No printed maps will be distributed at the trial.
- Print or type entries carefully, using BLACK or BLUE ink. The Club accepts no responsibility for incorrect or illegible entries. Entries that are received unsigned, without the proper entry fee or without both sides of the form, will not be accepted.
- No entries can be changed or refunded after the closing date.
- Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date, nor in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Trial Committee. If, because of riots, civil disturbances, fire, act of God, act of a public enemy, strikes, extreme weather conditions (including, but not limited to, extreme heat, snow storms or hurricanes) or any other act beyond the control of the management it is impossible to open or to complete the Trial, no refund of entry fee will be made. **Entries will be refunded only if the trial is cancelled due to COVID.**
- Acknowledgement of receipt of entries will be made soon after closing date. **Confirmations and judging schedule will be sent by email only.** Please include your email address on your entry form. Should such acknowledgement not be received by an exhibitor 5 days prior to the trial, please contact the Trial Secretary. (Please check your Spam/Junk folder before contacting the Secretary.)

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in

the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. - Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT
