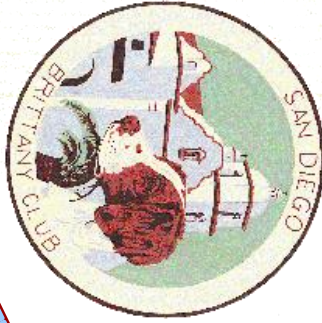

JUNIOR HANDLERS - \$30 entry fee for ALL STAKES

Note: If Junior ends up not handling, owner(s) will be required to pay entry difference prior to stake or dog will not run.

Stakes will be run on two courses, without bird fields. A blank will be fired in all stakes except Puppy. Quail or Chukar to be released in all stakes except puppy. Walking handling only in all stakes. AKC approved tracking collars will be permitted in all stakes, per AKC guidelines.
