NOTICES TO EXHIBITORS

The Show Site will be available to exhibitors at 12:00 p.m. on Sunday, Feb 16, 2020, and 7:30 a.m Monday, Feb 17, 2020,

STOCK

Ducks will be Indian Runner crosses. 5 ducks per run. Sheep will be Katahdin crosses. 5 sheep per run. Cattle will be Beef. 3 cattle per run No dog may be entered in two classes on the same course with the same kind of stock under the same judge at any trial.

Dogs must be removed from the trial site immediately following the conclusion of the trials each day.

These trials will be held outdoors. Please bring shade tents, chairs, crates, water for you & your dogs, and clean up items. A cool-off tub will be provided.

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all requirements safely. Dogs may not be left in closed vehicles without proper ventilation. If dogs are found in distress, SVCA will take appropriate action.

All dogs present must be held on leash or otherwise restricted except when working. Under NO circumstances will dogs be allowed to disturb the resting stock or interfere outside the arena during another dog's performance. (See Chapter 1, Section 20

of the AKC herding regulations.)Entry fees will not be refunded if a dog is absent, unless the dog is replaced by an alternate from the alternates' list; Disqualified; excused; or barred from competition by action of the Judge or Trial Committee.

No entry fees will be refunded if the trials cannot open or be completed because of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee. Swedish Vallhund Club of America reserves the right to cancel these trials in the event of extreme weather conditions and no entry fee refunds will be made in such case.

Owners are responsible for errors on completed entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. Changes, additions, or corrections to entry forms must be received in writing, by telegram or e-mail prior to the close of entries. Those received by telephone are not acceptable.

Telephone, e-mail, and unsigned entries cannot be accepted. Entries not on an Official AKC Entry Form and photocopies of entry forms without the Agreement and Rules of the Official AKC Form are not acceptable.

Post-dated and returned checks do not constitute a valid entry. A collection fee of \$35.00 will be added to the amount of each returned check.

No refund for duplicate entries. Care will be taken to find duplicates, however, if an entry has been processed, no refund will be made.

No entry shall be accepted which specifies any conditions as to its acceptance.

No alcoholic beverages allowed on the trial site.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the SVCA. No dogs under 6 months of age are permitted on the trial grounds.

Exhibitors alone are responsible for being at the trial arena gate when it is their turn to run. Judges are not required to wait for any dog.

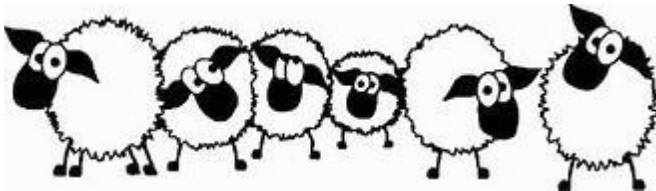
Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
